NOTICE OF PUBLIC HEARING

IN ACCORDANCE WITH TITLE XIII AND ADMINISTRATIVE RULE, LIQ. 208.02, THE NEW HAMPSHIRE LIQUOR COMMISSION WILL HOLD AN INFORMATIONAL LICENSING HEARING ON THE LIQUOR LICENSE APPLICATION OF V.M.O. INC D/B/A LAKE SHORE FARM INN, 275 JENNESS POND ROAD, NORTHWOOD NH. THE HEARING WILL BE HELD ON TUESDAY, MAY 14, 2024, AT 10:30 AM AT NORTHWOOD TOWN HALL IN THE PUBLIC MEETING ROOM, 818 FIRST NH TURNPIKE, NORTHWOOD, NH 03261

ANY INTERESTED MEMBER OF THE PUBLIC MAY TESTIFY AND PRESENT EVIDENCE IN FAVOR OF, OR AGAINST THE APPLICANT. THE COMMISSION WILL ANNOUNCE PROCEDURAL GUIDELINES AT THE PUBLIC COMMENTARY HEARING.

TESTIMONY WILL BE ALLOWED THAT IS RELEVANT TO THE FOLLOWING ISSUES:

- THE PROSPECTIVE LICENSEE;
- THE LOCAL GOVERNING AUTHORITY;
- THE PUBLIC, IN THE ORDER IN WHICH THEY SIGN UP TO SPEAK;
- THE COMMISSION MAY QUESTION SPEAKERS TO CLARIFY THEIR POSITIONS;
- THERE SHALL BE NO CROSS EXAMINATION OR REBUTTAL TESTIMONY; AND
- WRITTEN TESTIMONY SHALL BE ACCEPTED ONLY IF SIGNED AND RECEIVED PRIOR TO THE CLOSE OF THE HEARING.

PERSONS WISHING TO TESTIFY ARE URGED TO COORDINATE THEIR TESTIMONY TO AVOID UNNECESSARY DUPLICATION OR REPETITION OF TESTIMONY.
