Cases heard during this meeting:

Case: 21-4 Site and Sub: Chestnut and Cape, INC.

Chair Jandebaur called the meeting to order at 6:35 PM.

Minutes

July 8, 2021

Ms. B. Smith made a motion to approve the minutes of July 8, 2021. Ms. Baldwin seconded. Motion carried 4/0.

Conceptual Consultation

Scott Frankiewicz of NH Land Consultants presented a proposal for a subdivision for David Pelletier Construction on Old Turnpike and Olde Canterbury Road.

Mr. Burdin stated that they have received both the drainage peer review, and the legal peer review back. Mr. Burdin stated that he had sent an email to Geoff Aleva earlier that day asking how they would like to proceed.

Neil Rapoza from Civil Consultants was present to discuss this application, he stated that they are working on the comments, he wants to make sure they are addressing specifically what CMA had questions on.

Mr. Burdin stated that before they get into any discussion about conditions of approval, he would like to see a final plan set that the applicant is asking for a decision on. That would include a lighting plan, a landscape plan, and whether or not they would want to request a waiver for the lighting plan. Mr. Rapoza stated that they are going to be indicating that there will be downward shielded wall pack lighting on the individual structures. There will not be any light poles or street lights proposed. Mr. Jandebaur stated that he would like to know about the fire issue. Mr. Burdin has asked about this at a previous meeting. What has been addressed as far as fire suppression? Mr. Rapoza stated that he has only spoken to Mr. Aleva about this, so he didn't have any final comments yet. They were looking into whether or not a cistern

was necessary for fire protection. That's the most likely outcome. They will present that on the clean plan that will have everything addressed. He stated that they also want to be sure they are satisfying all of the DES requirements as well.

Public Comment

Ralph Blackey

"My concern is about the road. How it's going to be done from eastbound to Main Street. Is that going to be paved?"

Mr. Jandebour stated that there is no indication that that was going to happen.

Mr. Blackey:" That's good because the other day we caught a kid, called the cops. He left a brake mark probably 110 feet long, because I jumped out in front of him. He said that he was only doing 25 miles an hour. Sorry, 110 brake mark is not 25 MPH. If that road gets paved or anything, you'll have to widen the road. They just fixed the culvert down there, after 42 years. There's no way you can put a two-lane road down there, especially by that culvert. You can only fit one truck and that's about it."

Mr. Magoon

- *Traffic impact on Olde Canterbury Road? Culvert has interestingly been quickly replaced this summer but show signs of improper installation. (Drone pictures available upon request from abutter Ralph Blackey.*
- *Impact to wetland*
- *This is a question from an attorney, "What measures is the town taking if this project were approved, if there were to be septic failure/wastewater runoff issues into the brook, and ultimately running into the Northwood Lake Watershed?"*


CIP
