

# Northwood EMD's report for week prior to 11/15/21

Northwood saw another large increase in active cases (currently 20 active). Our 14-day new case total remains high (25). Deerfield maintains a high active case count (currently **68** active cases).

1) DHHS lists a **14-day count for new cases** for each town. For a town of Northwood's population, more than 2 cases would be a Moderate Transmission Rate. More than 5 cases would be a Substantial Transmission Rate. The11/15/21 14-day new case count for Northwood is at 25.



2) All NH counties are at **substantial transmission.** Today, Northwood had 20 active cases. There were 9 new cases added and 6 cases removed.

3) Today 11/15 cumulative confirmed count for New Hampshire is **146834** with 1630 total deaths and 138909 recovered cases for a working total of 6295 active cases.

Friday 11/12 cumulative confirmed count for New Hampshire is **144626** with 1622 total deaths and 136538 recovered cases for a working total of 6466 active cases.

The current number of hospitalized COVID-19 cases is **260**. Wednesday's count was at 255. New Hampshire has 54.9 % of its population fully vaccinated. Northwood has 52.5 % of its population fully vaccinated.
