Warrant for Meeting of Village District Residents
To See if They Will Establish a Village District

To the inhabitants of the Town of Northwood in the County of Rockingham in the State of New Hampshire with driveways that access Lynn Grove Road, Woods Road, Fiore Road and Lynn Lane, qualified to vote in Town Affairs:

You are hereby notified to meet at the **Town Hall** in said Northwood on **Tuesday, September 25, 2018 at 6:00 PM**, to act upon the following:

ESTABLISHMENT OF VILLAGE DISTRICT

Article 1: To see if the residents will vote to establish a village district pursuant to RSA 52 consisting of all properties with driveways that access Lynn Grove Road, Woods Road, Fiore Road and Lynn Lane for the purpose of maintaining Lynn Grove Road, Woods Road, Fiore Road and Lynn Lane. The properties included in the village district are shown on Tax Maps 112, 113, 115, 116, and 118 and are specifically identified as the following tax lots:

Article 3: If Article 1 passes, to choose necessary officers for the village district to hold office until the first annual meeting of the district.


OTHER BUSINESS




