- A. Organization This document referred to as a Request for Proposals, is divided into the following parts:

- B. Although an attempt has been made by the town to provide accurate and up-to-date information, the Town does not warrant or represent that the background information provided herein reflects all conditions related to this invitation.
- C. All proposals are to include any cost associated with this project including but not limited to materials, equipment, freight, delivery, dealer preparation, set-up and labor.

Specifications:

- A. Unless otherwise specified, the unit shall be a new 2024 or 2025 RAM 5500, 4X4 in new undamaged condition.
- B. A complete set of specifications of the unit, descriptive literature, date of delivery, and warranty information shall be included in the submittal. A window sticker shall be delivered with the vehicle. All deviations or variances from the above specifications shall be expressly identified and explained. Failure to provide this information may result in a proposal not being accepted or considered.
- C. The old chassis will be returned to the town. The town will arrange transportation.

Submission Information:

The Town welcomes all interested parties to participate in this competitive process. Submitters will be expected to submit proposals that are in compliance with the terms and conditions as outlined below:

- A. All awards are subject to final approval of the Town Board of Selectmen.
- B. Proposals must be delivered on or before the date stipulated in the RFP. All late proposals will be rejected regardless of post mark or tracking documentation.
- C. The town reserves the right to reject any and all proposals.

The town is authorized to contact these references regarding their service and sales experience, quality of product and workmanship.
- K. All equipment shall remain the property of the seller until delivered to and accepted by the Town. Equipment supplied by the Town shall remain the property of the Town.
- L. All submitters must submit written evidence of qualifications to finish the project. Submitters may be required to provide evidence of adequate financial and technical ability to provide the services described.
- M. Submitters must describe how and where to obtain a warranty service after the sale, where and how to obtain spare parts or services.
- N. Each submittal must include copies of all warranties to be provided by the manufacturer, distributor, or dealer. Failure to provide these requirements could result in rejection of the proposal.
- O. All proposals must include all items listed as "standard" and typically included as part of the ambulance remount regardless of the attached specifications.
- P. The Town and the successful bidder will agree to an accepted delivery date. A penalty of \$100 per day will be applied for each day beyond the agreed upon delivery date.
- Q. Payment to be made upon delivery and successful inspection and acceptance by the town of Northwood.
